ADOPTION OF BUDGET FOR FISCAL YEAR 2024-2025

WHEREAS, on August 28th, 2024, the Board of Commissioners of the Worley Fire Protection District conducted a public hearing for consideration of a proposed budget for the fiscal year beginning October 1, 2024, and ending September 30, 2025, pursuant to the Idaho Code Section 31-1422; and

WHEREAS, the proposed budget has been reviewed and approved by the Board of Commissioners of the Worley Fire Protection District, and,

WHEREAS, the proposed budget has been posted for public review and advertised as required by Idaho Code Section 31-1422, and,

WHEREAS, the proposed revenues are summarized as follows:




